HOLD HARMLESS AGREEMENT OF PARENT(S) OR GUARDIAN(S)

I (we) the undersigned, parent (parents) or guardian (guardians) of the above-named child, a minor, acknowledge an awareness that the Children's Nature Studies is sponsored and supervised by the South Texas Botanical Gardens & Nature Center., a non-profit corporation dedicated to public purposes, one of which is to provide such an experience for minors; that the STBGNC and its employees and volunteers as well as its officers and directors would not be able to provide such an experience if it or they or any of them had to bear the risk of being liable in money damages for any sickness, injuries or damages that might be incurred by the minor participant. I (we) while understanding that the STBGNC does not anticipate any sickness, injuries or damages to any of the participants, such sickness, injuries or damages may occur. Therefore, knowing that the STBGNC, its employees, volunteers, officers and directors can neither afford to insure or stand liable for any sickness, injuries or damages that may arise by reason of any careless or negligent act or failure to act of any such person, I (we) agree to assume all risk of injury or damages to the above-named child occurring as the result of any careless or negligent act or failure to act of any of such persons; and I (we) agree to hold the STBGNC, its employees, its volunteers, officers and directors harmless from and indemnified as to any claim or action for damages brought by the Camper, the undersigned, or any other person claiming by reason of any sickness, injury or damage to the child or child's property arising from or as a result of any such careless or negligent act or failure to act. I (we) also authorize use of photos for Botanical Gardens publicity.

If discipline problems occur, the STBGNC reserves the right to notify parent or guardian and, if in STBGNC's judgment advisable, prohibit child from completing the week's session, without refund.
